MARKOVER HUNTING PRESERVE, 699 Cook Hill Rd Danielson, CT

- From the Mass Pike in Auburn exit off pike.
 Rt 395 South exit 41. Off Rt 395 turn left at end of ramp. Take first right past Zip's Diner. Take fourth right on to Cook Hill RD. Proceed ½ mile to Markover on the right
- From Hartford area, Take Rt 84 to exit 69, take right onto RT 74. Follow to the end. Take Left onto Rt 44. Follow 44 to Rt 101, and pass under Rt 395. Take first right after Zip's Diner. Take fourth right to Cook Hill Rd. Proceed 1/2 mile to Markover on the right.
- From Rt 95 and South Rt 95 to Rt 395, exit 41. Take right at the end of the ramp Take first right after Zip's Diner, then fourth right onto Cook Hill Rd. Proceed ½ mile to Markover on the right.
- From Providence and East: Take Rt 6 to Rt 101 Turn left 3.7 miles after Welcome to CT sign onto Cook Hill Rd. Proceed ½ mile, and Markover is on the right.

Note: Limited camping on grounds, must be reserved in advance.
